It is Jam & Brooks Gifts Ltd's policy to respect your privacy regarding any information we may collect while operating our website. This Privacy Policy applies to [www.fantastc-gifts.co.uk](http://www.fantastc-gifts.co.uk) (hereinafter, "us", "we", or "[www.fantastc-gifts.co.uk](http://www.fantastc-gifts.co.uk)"). We respect your privacy and are committed to protecting personally identifiable information you may provide us through the Website.
